## INCIDENT - SUPPLEMENTAL NARRATIVE

On 6/21/2017 at approximately 1942, I was dispatched to 2424 Banyon Dr. reference a harassment complaint. Upon arrival, I made contact with the reporting party (Sarah Kerns) who advised she was previously employed by a company in North Carolina called Invenergy. Sarah moved back to Ohio from North Carolina in November 2016 and left the company in December 2016. Sarah was a Notary Public during her time at Invenergy and notarized a form on 7/22/2016 involving a controversial land lease for a solar farm.

Sarah advised she'd been contacted six times on 6/21/2017 by an investigative reporter (Don Carrington) for the Carolina Journal. Sarah advised she received the calls on her work phone while at work for the City of Dayton. Sarah advised she contacted Dayton PD who referred her to BPD. Don told Sarah that he believed Invenergy forced her to notarize the form even though the parties needed to sign the form were not present. Don threatened to make Sarah part of his news story if she did not supply a comment.

I contacted Don who advised he'd have no further contact with Sarah or could face potential telecommunications harassment charges. Don believed he was closer to the truth because BPD had to be involved.
